| 119.1 | <i>Land adjacent to Chandlers:</i> a copy of the decision notice for this planning application has been obtained. There does not appear to have been any condition placed with regard to the re-planting of trees. The Parish Council therefore feels unable to pursue this matter any further. | 122 | RENOVATION OF SCHOOL PLAYING FIELD: The Council voiced concerns that this remains an outstanding issue and has for a considerable length of time. The Clerk was instructed to write to Mr Mike Harris to enquire if any progress has been made with existing grant applications and if the Council could have copies of these for the next meeting.  |
| 123 | PROPOSED TOILET CLOSURE: District Councillor Andrew McCloy informed the Council that planning permission for the proposed new toilets in the surrounding towns has been applied for. The Committee responsible is at present working on a budget for these. From then it will be decided how many village toilets will need to be closed to fund this budget. All present at the meeting voiced their dissatisfaction at this information and will continue to oppose the proposal. Cllr McCloy will keep the Clerk informed of any developments on this matter. |
| 124 | REGISTRATION OF PARISH LAND: Progress on this matter is difficult due to cost implications. Cllr Leach will continue to look into this matter and the Council will review in May.  |
| 125 | AREA COMMUNITY FORUMS: Noted.  |
| 126 | PARISH AND TOWN COUNCIL ELECTIONS: Members discussed the forthcoming elections in May and whether Poll Cards will be required. The Chairman and the Clerk agreed to look into this further.  |
| 127 | RECENT BREAK-INS: The Parish Councillors ask parishioners to be extra vigilant following some recent break-ins to properties within the district. If anyone witnesses or suspects anything suspicious they are advised to contact the police.  |
| 128 | VILLAGE GREEN: It has been noted that part of the village green is being damaged by parking. The Clerk was instructed to look into the purchase of a sign to ask people not to park on the grass.  |
| 129 | LONG RAKE SAFETY: Cllr McCloy reported that he has met with two Senior County Councillors and a Highway Officer on the Long Rake road to highlight dangers to motorists which have resulted in road traffic accidents. Possible solutions discussed were widening of the carriageway, filling in pot-holes and erecting warning signs for motorists. Cllr McCloy will keep the Parish Council informed of any updates.   |
