6	<p>RENOVATION OF SCHOOL PLAYING FIELD:</p> <p>The Council has received a conditional offer from The Big Lottery Fund following the recent Awards for All grant application. The Council now needs to send several documents required in order for the grant to be confirmed. The Clerk will attend to this imminently.</p> <p>With regard to the Aggregates Levy Grant Cllr Mrs Scoggins has received the further two quotes required and has the matter in hand. The required completion date the project, set by the Aggregates Levy Board has now been extended to November.</p> <p>The walling around the school field is still in progress and it has been noted that Mr Mellor is doing an excellent job. Stone provision is now no longer an issue as local farmers Bernard Woolley and Bernard Frost have donated the amount required. The Council wishes to express sincere gratitude for their generosity.</p>

7	VILLAGE TOILETS: The renovation of the toilets by DDDC's Community Services is now complete. The strip drain outside the front of the building has been replaced and a 2 ft high retaining wall built to further deflect water. They have been fully decorated inside and new doors fitted. Regular cleaning will now commence twice weekly by DDDC.
8	VACANCY FOR PARISH COUNCIL: Cllr Bob Woolley has now formally retired from the Council, his last meeting having been the Annual Parish Meeting preceding. During the APM the Chairman expressed her sincere gratitude to Cllr Woolley for his 26 years of service and dedication and expressed he will be greatly missed. Cllr Woolley's resignation now creates a vacancy within the Council. The Clerk will advertise the vacancy as per DDDC's Electoral Services procedure on the village noticeboard. One local resident has expressed an interest in the vacancy.
9	VILLAGE MARKET DAY: This year's Village Market will be held on Monday 27 May. Ashbourne Town Band have been booked to play at 2pm on the day. The Clerk will forward the deposit to the secretary. The Clerk was instructed to write to Mrs Edwards of the Market Committee to request a list of stallholders and enquire if they hold insurance.
10	THE RALPH RIDER AND PALFREYMAN TRUST: The Clerk has received a notification from the Trust that Cllr Mrs Frost has come to the end of her term as a Parish Council representative. Cllr Mrs Frost is willing to continue in this role therefore the Parish Clerk will notify the Clerk to the Trust of this.
